#### Location

The premises are situated on the north side of Hutton Road directly opposite Shenfield Station with direct links to Liverpool Street, London (within 24 minutes). Nearby retailers include Tesco Express, Subway, Costa Coffee and Co-Op.

## Accommodation

The premises comprise of modern office space forming the first floor of a two storey building which has a retail unit on the ground floor and further offices above at second floor. The property benefits from double glazed windows, a door entry system and air conditioning. A communal kitchenette is situated on the second floor and wc's on the first which are shared between the two floors. Two allocated parking spaces are located to the rear of the premises.
